HOW TO APPLY FOR A PERMIT

In order to apply for the Water Board's Cannabis Cultivation Permit, the following information is required:

CONTACT INFORMATION

- Name, address, phone number and email for:
 - Site operator/cultivator
 - Land owner
 - Agent/consultant

LEGAL NAMES

- Cultivation site
- Person/business cultivating
- Person/business who is the land owner

WATER SOURCE INFORMATION

- Groundwater, municipal supply, and/or surface water?
- **If surface water** - water body name and location, stream characteristics, method of water diversion, water storage

GROW SITE INFORMATION

- All Sites:
 - Assessor's Parcel Number (APN)
 - Industrial wastewater disposal method
- Outdoor Grows:
 - Acreage/square feet of total disturbed area and cultivation area
 - Slope of disturbed area and area to be graded
 - Wastewater disposal method
 - Wetland/riparian setbacks
 - Volume of water for crop irrigation and rate
 - Number and volume of water storage vessels
