5. Update from the Laboratory Subcommittee

Laboratory Subcommittee **Chair Frazier** gave an update on the February 21st meeting. The Chair and the committee discussed several issues raised by the Laboratory Subcommittee, including LOD/LOQ requirements, sample weight minimums, and allowing labs to set their own methods of testing so long as they meet equivalency criteria. **Chair Frazier** presented his proposed motions for the committee to adopt:

- 1. Remove the requirement to run the initial extract or filtrate, or removing the dual dilution requirement.
- 2. Adjust the LCS requirement to not require every analyte, or move strictly to a matrix post dilution spike.
- 3. Increase the minimum sample wright to 500 mg, and include an acceptable range for the mass.
- 4. Set an equivalency criteria so that labs may use their own methods while honoring the intent of SB 544.

Member Christensen moved to adopt the recommendations. The motion was seconded by **Member Dr. Brown**.

Chair Jamalian opened the floor for public comment.
