# **Executive Summary**

Business and Professions Code section 26190 established annual reporting requirements for the Department of Cannabis Control (Department). Beginning March 1, 2023, and annually thereafter, the Department must prepare and submit to the Legislature an annual report on activities within the Department for the prior fiscal year.

The report also provides updated data about the Equity Fee Waiver and Deferral Program for the prior fiscal year.

Finally, the enclosed report includes the Department's responses pursuant to the Budget Act of 2022 under the Business, Consumer Services, and Housing Item 1115-102-0001, which requires the Department to provide a report on the Cannabis Local Jurisdiction Retail Access Grant Program beginning in 2023 and until 2026.



# **Annual Report**

As required by section 26190 of the Business and Professions Code and Item 1115-102-0001 of the Budget Act of 2022, the Department submits the following information regarding its activities. This report contains the required information and data for the prior fiscal year, July 1, 2023, to June 30, 2024.

# (a) The amount of funds allocated and spent by the department for cannabis licensing, enforcement, and administration.

The Department allocated \$166,387,000 for cannabis licensing, enforcement, and administration and expended \$142,319,000.

# (b) The number of state licenses issued, renewed, denied, suspended, and revoked by state license category.

- Issued: 712 licenses
- Renewed: 8,939 licenses
- Denied: 5 applications
- Suspended: 125 licenses
- Revoked: 51 licenses

# (c) The average time for processing state license applications by state license category.

- Cultivation Licenses: 263 days
- Manufacturing Licenses: 367 days
- Distribution Licenses: 250 days
- Testing Laboratory Licenses: 797 days
- Retailer Licenses: 212 days
- Microbusiness Licenses: 320 days
- Event Organizer Licenses: 221 days
- Temporary Cannabis Event Licenses: 72 days

The average application processing time for most license activities has increased from the prior fiscal year. Several factors contribute to these delays, including the statutorily mandated transition to annual licensing requirements and challenges experienced during the application review process.



As of January 1, 2023, applicants must comply with all annual license requirements before the Department may issue an annual license. This includes completion of California Environmental Quality Act (CEQA) reviews. Additionally, starting January 1, 2024, retail license applicants who qualify under a local equity program may resume applying for new provisional licenses. The department will continue to issue new provisional licenses for retail activities to those who qualify under a local equity program until January 1, 2031. These provisional licenses can be renewed for a maximum of five years from the date of original issuance.

Beyond meeting enhanced annual licensing requirements such as CEQA, the Department continues to experience challenges with applicants failing to respond promptly to Department inquiries and submitting incomplete application documentation. These issues are further compounded by the need to verify the accuracy of applicant-submitted records and coordinate with local and state regulatory partners to confirm compliance with statutory and regulatory requirements. The resulting follow-up and verification processes can significantly impact licensing timelines.

Testing laboratory applications are a notable outlier given the complexity of the license review process. These applications require submission and review of comprehensive standard operating procedures and method validations that demonstrate compliance with rigorous regulatory testing standards.

- (d) The number of appeals from the denial of state licenses or other disciplinary actions taken by the department and the average time spent on these appeals.
  - Appeals from the denial of a state license: 5
  - Appeals from other disciplinary actions: 5
  - Average time spent on appeals: Approximately 30 hours of Department staff time was spent on each appeal
- (e) The number of complaints submitted by citizens or representatives of cities or counties regarding licensees, provided as both a comprehensive statewide number and by geographical region.

The Department received 14,133 complaints statewide. See Exhibits 3 and 4 for additional detail.

(f) The number and type of enforcement activities conducted by the department and by local law enforcement agencies in conjunction with the department.



Since the Department consolidated in July 2021, the Enforcement Division has seized over \$2.2 billion worth of product from the illegal marketplace and has significantly expanded law enforcement actions.

In FY 23/24, the Enforcement Division led and assisted in the service of 481 search warrants. As a result of these actions, a total of 379,937 pounds of untested cannabis product was seized, which included the eradication of 570,063 plants, worth an estimated retail value of \$636,029,330. In addition, these search warrant operations resulted in the seizure of 192 firearms, 106 arrests, and the seizure of \$1,880,886 in cash.

Of these, the Department was the lead agency in 237 of these operations. In the Department-led operations, a total of 116,934 pounds of cannabis was seized, 167,545 plants were eradicated, 87 firearms were seized, and 35 arrests were made. The total estimated retail value of the seized product and plants was \$200,071,941. Of the remaining 244 operations in which the Department assisted, a total of 263,003 pounds of cannabis was seized, 402,518 plants were eradicated, 105 firearms were seized, and 71 arrests were made. Additionally, the Department's Compliance Division assisted in the service of 276 search warrants to support local or state law enforcement to address primarily unlicensed cultivation activity. These actions resulted in the Department issuing 17 administrative citations, the seizure of 51,427 pounds of cannabis product and 463,725 plants, and 44 arrests. The total estimated value of the seized product and plants was \$467,427,675.

# (g) The number, type, and amount of penalties, fines, and other disciplinary actions taken by the department.

During the annual reporting period, the Department issued the following:

# (h) The number of licenses on which the department imposed conditions and the categories of conditions imposed on licenses.



The Department did not impose conditions upon any licenses.

#### (i) A detailed list of the petitions for regulatory relief or rulemaking changes received by the department from licensees requesting modifications of the enforcement of rules under this division.

The Department received one petition submitted pursuant to Government Code section 11340.6. The petitioner requested amendment of existing regulations governing ingredients permitted to be used in manufacturing edible products to harmonize them with existing, more expansive regulations that allow additional ingredients to be used in manufacturing other cannabisinfused products (e.g., tinctures). The Department denied this petition on its merits in accordance with Government Code section 11340.7.

(j) A list of interstate cannabis agreements entered into pursuant to Chapter 25 (commencing with Section 26300), including information regarding the terms and conditions of each agreement, the activities undertaken by state agencies to implement the agreement, and the effects of the agreement on California's cannabis industry.

There are currently no interstate cannabis agreements to report.

# (k) The number of licensees awarded an equity fee waiver or deferral and the amount of money spent.

Equity businesses in California may be eligible for a license fee waiver or deferral from the Department if they meet certain criteria. To be eligible, individuals must satisfy the statewide equity criteria, which allows businesses to qualify through cannabis convictions or arrests, household income, or by living in an area disproportionally impacted by the War on Drugs. Applicants may also be eligible if they are locally verified as an equity business and attest that they too satisfy the criteria set forth in the statewide definition.

Equity fee waivers have been available to applicants and licensees since January 2022, and fee deferrals became available in January 2023. During FY 23/24, the Department awarded:

- 764 fee waivers
- 572 fee deferrals

A total of \$3,773,761 was available and spent on equity fee waivers, with funding fully exhausted as of February 2024.

Please note: Although fee waiver funding is no longer available, eligible equity applicants and licensees may still apply for fee deferrals.



(I) The 2022 Budget Act, Item 1115-102-0001, the Cannabis Local Jurisdiction Retail Access Grant Program. The Department must report on the (1) information on the amount of funds allocated to local jurisdictions, (2) how the local jurisdiction plans to utilize the funds, (3) the progress, if applicable, of local cannabis retailer licensing programs and the number of retailers permitted in the local jurisdiction, and (4) the number of equity licensee retailers operating within the local jurisdiction.

The 2022 Budget Act, Item 1115-102-0001, allocated \$20 million to support local jurisdictions without cannabis retailer licensing programs in developing such programs and permitting cannabis retailers.

In Phase I of the Retail Access Grant Program (Grant Program), the Department awarded \$4,145,000 to 18 local jurisdictions to establish retailer licensing programs.

Phase II was intended to distribute the remaining grant funding to cities and counties based on the number of retailer and equity retailer permits issued. However, the Budget Act of 2024 (Item 1115-495) reverted \$16,470,000 of uncommitted funds from the Grant Program back to the General Fund.

Before this reversion, the Department received only one Phase II application. The Department awarded \$300,000 to the City of Healdsburg in Phase II for the issuance of two retailer licenses.

With all Grant Program funding now exhausted, no additional applications will be accepted, and no further funding will be awarded.

#### (1) Information on the amount of funds allocated to local jurisdictions

In Phase I, up to \$10 million in initial grant funding was available for eligible local jurisdictions to develop and implement a cannabis retail licensing program. The Department began accepting applications for Phase I of the grant program on March 10, 2023, and the application process closed on April 28, 2023.

During the Phase I application period, the Department received 20 applications from local jurisdictions for grant funding. One jurisdiction withdrew their application prior to the close of the application period, and one jurisdiction was deemed ineligible because it had an existing retailer licensing program.



On June 20, 2023, the Department awarded a total of \$4,145,000 to 18 local jurisdictions to develop and implement local cannabis retailer licensing programs. Grant funding was awarded based on the population size of the jurisdiction and whether a jurisdiction was proposing equity assistance. Of the 18 jurisdictions, 14 selected for awards proposed equity programs to support and assist the licensure of cannabis equity retail businesses, a critical component to further equity in the legal cannabis market. Of the \$4,145,000 awarded, \$870,000 was awarded as equity bonus funding to be used for the benefit of equity applicants and licensees.

To date, four jurisdictions have withdrawn their application post-Phase I award. The City of Buena Park informed the Department that they would not be moving forward with the grant because its city council indicated that there were several other priorities they wanted to focus on. The Huntington Beach City Council voted 4-3 against adoption of the draft resolution to accept the award. Similarly, Lodi City Council indicated they were pursuing other priorities and did not plan to move forward with a cannabis retail program. Additionally, the Department was not able to obtain necessary grant contract documents from the City of Avenal after being awarded Phase I funding, resulting in their award being withdrawn. Therefore, the grant awards for these jurisdictions, totaling \$1,030,000, were withdrawn. This brought the total Phase I award amount down to \$3,115,000.

In January 2025, the City of Calabasas informed the Department that they would not be moving forward with establishing a local cannabis retailer licensing program due to community opposition toward cannabis retail.

In Phase II, an additional \$10 million, and all remaining Phase I funding, was available to eligible local jurisdictions based on the number of retailer and equity retailer licenses issued. However, the Budget Act of 2024, Item 1115-495, reverted all uncommitted Grant Program funding back to the General Fund. Only one Phase II application was received prior to the reversion of funds. The Department awarded \$300,000 to the City of Healdsburg for the issuance of two retailer licenses. With the reversion of funding, no additional funding is available to award and no additional applications will be accepted.

#### (2) How local jurisdictions plan to utilize the funds

Phase I awardees will use grant funding to draft and adopt ordinances to allow the establishment of cannabis retail businesses within the jurisdiction, hire staff and contractors, hold community outreach and engagement events, survey local populations, form stakeholder workgroups or technical advisory committees, conduct economic studies and environmental reviews, develop



application forms and online application portals, and process and issue cannabis retail licenses.

Equity funding will be used by jurisdictions to conduct equity assessments, establish local cannabis equity programs, develop infrastructure to support and prioritize equity applicants, provide financial assistance to equity applicants and licensees in the form of fee waivers and deferrals, provide translation services, and provide technical assistance, such as legal and financial guidance assistance, with local and state applications and compliance training.

Explanations of disciplinary actions



## **Explanations of Disciplinary Actions**

A **Letter of Warning** is issued to a licensee when the Department has direct or indirect evidence that the licensee is violating statute or the regulations. The document is used to warn licensees that they will face disciplinary action if they continue with activities that are in violation with statute or regulation. The Department encourages licensee compliance through education and outreach.

A **Notice to Comply** is issued to the licensee to address violations identified during an inspection or investigation. These notices can require that a licensee provide the Department with a written corrective action plan to address violations and the Department develops a timeline for which a licensee must correct any identified violations. If this timeline is not met, the Department may take disciplinary action.

An **Administrative Citation** is issued to notice and document a violation and can contain monetary fines and/or abatement orders. The Administrative Citation can be used independently or in conjunction with an embargo, suspension, or other disciplinary or enforcement action. Citations are generally used as part of the progressive discipline process, in cases where the licensee has been unsuccessful in correcting identified deficiencies within the allotted time frame required in a Notice to Comply. However, the Department may move directly to a citation depending on the severity of a violation.

An **Embargo** is a tool used to prevent the movement or disposal of cannabis and cannabis products while an investigation in underway. At the point an embargo is placed, the Department only needs to have probable cause to believe the cannabis or cannabis products placed under embargo are adulterated or misbranded or the sale would otherwise be in violation of the Act or the regulations.

A **Voluntary Condemnation and Destruction** is when the licensee or owner of the cannabis or cannabis product (product owner) voluntarily chooses to destroy cannabis and/or cannabis product subject to an embargo.

A **Mandatory Recall** is when the licensee must immediately remove cannabis or cannabis product subject to the Mandatory Recall from the commercial supply chain. The Department posts recall information on its website and sends a consumer advisory to licensees and consumers.
