# Supplemental Budget Report of the 2021-2022 Budget Act

As required by the 2021-22 Budget Act, under the Business, Consumer Services and Housing Item 1115-001-3288, on or before March 1, 2023, and annually thereafter through 2025, the Department of Cannabis Control (Department) shall submit a report to the fiscal, budget, and relevant policy committees of the Legislature and the Legislative Analyst's Office and post the report on its website.

This report contains the required information and data, disaggregated by local jurisdiction, for the prior fiscal year, July 1, 2023 to June 30, 2024.

## **(i) The total number of active annual licenses.**

The Department had 6,055 active annual licenses. Of these, 2,940 were issued to licensees within a city, 3,073 were issued to licensees within a county, and 42 were issued to cannabis event organizers that do not have a reportable local jurisdiction. See Exhibit 1.

## **(ii) The total number of active provisional licenses.**

The Department had 3,011 active provisional licenses. Of these, 1,881 were issued to licensees within a city, 1,130 were issued to licensees in a county, and zero were issued to cannabis event organizers that do not have a reportable local jurisdiction. See Exhibit 2.

## **(iii) The total number of provisional licenses that transitioned to annual licenses.**

The Department transitioned 1,238 provisional licenses to annual licenses. A provisional license is transitioned to an annual license when full compliance with annual licensure requirements, including the California Environmental Quality Act (CEQA), is achieved and if issuing the license does not violate any local ordinance or regulation. ## **(iv) The total number of provisional licenses renewed that did not result in a licensee holding multiple cultivation licenses on contiguous premises exceeding one acre of total canopy for outdoor cultivation or 22,000 square feet for mixed-light or indoor cultivation.**

A total of 1,687 provisional licenses were renewed that did not result in a licensee holding multiple cultivation licenses on contiguous premises exceeding one acre of total canopy for outdoor cultivation or 22,000 square feet for mixed-light or indoor cultivation. See Exhibit 4.



**(v) The total number of provisional licenses renewed that resulted in a licensee holding multiple cultivation licenses on contiguous premises exceeding one acre of total canopy for outdoor cultivation or 22,000 square feet for mixed-light or indoor cultivation.**

A total of 161 provisional licenses were renewed that resulted in a licensee holding multiple cultivation licenses on contiguous premises exceeding one acre of total canopy for outdoor cultivation or 22,000 square feet for mixed-light or indoor cultivation. The 161 provisional licenses represent 27 unique businesses. Additionally, as of June 30, 2024, 23 of those licenses remain active.

The 23 licenses that are still active were mistakenly renewed after the statutory deadline described in Business and Professions Code section 26050.2, subdivision (g)(1) had passed. The Department's licensing system technology is limited in its ability to identify and associate records for licenses held on parcels in close physical proximity. As a result, staff implemented procedures to manually identify and tag relevant licenses held on contiguous premises; however, manual data-entry procedures are subject to human error. After this error was recognized, the Department's licensing staff initiated a comprehensive review of cultivation licenses to identify any remaining contiguous premises exceeding the prescribed limits and resolved the issue. See Exhibit 5.

**(vi) The total number of provisional licenses that were not renewed for failure to meet the renewal requirements in Business and Professions Code section 26050.2 and the aggregated reasons those licenses were unable to be renewed.**

There were no provisional licenses that were not renewed for failure to meet the renewal requirements in Business and Professions Code section 26050.2.

**(vii) The total number of provisional licenses that were revoked or suspended pursuant to Business and Professions Code section 26050.2 subdivision (i).**

The Department suspended or revoked 99 provisional licenses pursuant to Business and Professions Code section 26050.2, subdivision (i).

**(viii) The total number of revoked or suspended licenses pursuant to Business and Professions Code section 26050.2 subdivision (i) on or after July 12, 2021.**

The Department revoked or suspended 123 provisional licenses pursuant to Business and Professions Code section 26050.2, subdivision (i) on or after July 12, 2021. See Exhibit 6.



**(ix) A narrative explanation of any of the trends displayed in the data provided, including how they might differ from previous years.**

Notable trends compared to data in the previous reporting period are as follows:

- The total number of active annual licenses reported in subdivision (i) represents a 16.1 percent increase in the total number of active annual licenses relative to the number of active licenses in the previous reporting period.
- Provisional licenses comprised 33 percent of all licenses, with 40.8 percent of these provisional licenses located in the City of Los Angeles. This represents a 43.8 percent decrease in the total number of provisional licenses from the previous reporting period. Annual licenses now comprise over two-thirds (66.9 percent) of all licenses.
- Over half of the provisional licenses (56.5 percent) that transitioned to annual licenses were located in local jurisdictions awarded Local Jurisdiction Assistance Grant funding in January 2022 to assist in completing requirements necessary to transition annual licensure, including CEQA compliance. (Exhibit 7)
- The number of provisional licenses transitioned to annual licenses during the previous reporting period is decreasing, as the total number of outstanding provisional licenses gets smaller. The three jurisdictions with the largest number of transitions from provisional licenses to annual licenses were the County of Humboldt (with 133 transitions), the County of Monterey (with 117 transitions), and the County of Trinity (with 112 transitions). All three of these jurisdictions are recipients of Local Jurisdiction Assistance Grant funding.
- The three jurisdictions with the greatest number of remaining provisional licenses are the City of Los Angeles (with 1,221 provisional licenses), the County of Mendocino (with 553 provisional licenses), and the County of Humboldt (with 201 provisional licenses).
